BRIDGE COURSE REPORT - 2022 -23

The Research & Post Graduate Department of Commerce. Mahatma Gandhi College, Thiruvananthapuram, was organizing a week-long Bridge Course every year, to the first year B.Com, students on Commercebefore the commencement of the first semester classes. The main objective of the course is to bridge the gap between subjects studied at Pre-university level like basics of Accountancy. Business Mathematics, Management and Statistics and to acquaint students with new subjects that they have not studied before. The classes wereaimed to guide fresher's in teaching them the concepts.

The syllabus for the course is framed in such a way that equal importance is given to both Commerce discipline. Career and Personality development which includes soft skills, and cultural activities. The duration of this course is 5 days with 15 hours. The first session of Bridge course regarding Introduction to Commerce include an introduction of commerce, accounting, management, financial institutions, auditing, etc. it aims to provide an overall understanding of different dimensions of management process. The second session on Introduction to taxation deals with meaning and features of direct and indirect tax, and various other provisions relating to taxation. It aims to facilitate an overall understanding about the fundamental concepts of taxation. The third session deals with higher education and career development on commerce, which aims to enable the students to acquire the knowledge about higher education options and career opportunities in Commerce education.

The bridge course classes are very important to assist lecturers in ensuring that the entire class has some prerequisite knowledge before starting the core concepts of the syllabus. The students also can confidently take up classes and understand the concepts more coherently. Bridge Course will help the students to have a smooth transition to the B.Com degree course. The sound grasp of the fundamentals of the commerce subjects lays the strong foundation for the entire three year programme. Our experience has shown that students who underwent the bridge course have fared extremely well in University Examinations. Also the students who have attended the bridge

course in the previous years have appreciated the initiative usefulness. Other academicians and industrial persons who visit our department regularly have acclaimed it as an eye opener and boosts confidence significantly.
